Reference nosilca / Lecturer's references:

Gorazd Justinek je docent za področje mednarodnega poslovanja in docent za področje mednarodnih političnih, ekonomskih in poslovnih odnosov. Je nekdanji diplomat in ustanovni član Sektorja za gospodarsko diplomacijo na Ministrstvu za zunanje zadeve. Vrsto let je bil vodja sektorja za internacionalizacijo na Javni agenciji RS za podjetništvo in tujne investicije ter v času predsedovanja Slovenije EU opravljal delo svetovalca predsednika vlade za področje domačih makroekonomskih ter mednarodnih ekonomskih odnosov. Po vstopu Slovenije v OECD je koordiniral delo predstavnikov Slovenije v delovnih telesih OECD, sodeloval pri pripravi programskega proračuna Republike Slovenije ter makroekonomskih analizah in reformah v javni upravi. Dva mandata je bil tudi direktor nevladne Ustanove - Center za Evropsko prihodnost, ki prvenstveno izvaja mednarodno razvojno pomoč v državah ZB in je tudi nosilka več Horizon 2020 projektov. Je ustanovitelj in odgovorni urednik mednarodne znanstvene revije <i>International Journal of Diplomacy and Economy</i> (London), ter član uredniških odborov številnih drugih

mednarodnih znanstvenih revij (Scopus in WoS).

Gorazd Justinek is assistant professor of International Business and assistant professor of international political, economic and business relations. He is a former diplomat and a founding member of the Division for Economic Diplomacy at the Ministry of Foreign Affairs of the Republic of Slovenia. He has been for several years also the Head of the Division for Internationalisation at the Public Agency of the Republic of Slovenia for entrepreneurship and foreign direct Investments and during the Slovenia's EU Council Presidency in 2008 the domestic macroeconomic and foreign economic relations adviser to the Prime Minister of the Republic of Slovenia. After Slovenia's accession to the OECD, he became the coordinator of Slovenia's representatives in the institutional bodies of the OECD in Paris and worked on the programme budget of Slovenia, macroeconomic analysis and reforms in public sector. For two mandates he was the CEO of a non-governmental Foundation – Centre for European Perspectives, the key implementation body of the Republic of Slovenia's development assistance in the Western Balkans and a research centre with several Horizont 2020 projects. He is the founder and Editor in Chief of *International Journal of Diplomacy and Economy* (Geneva), and a member of several other editorial boards of international scientific journals (Scopus and WoS).

Prof. dr. Janez Šušteršič je redni profesor ekonomije. Med leti 2000 in 2007 je bil direktor Urada za makroekonomske analize in razvoj ter v letu 2012 minister za finance. Koordiniral je pripravo dveh razvojnih strategij Slovenije ter bil podpredsednik Odbora za ekonomsko politiko pri Svetu finančnih ministrov EU. Predaval je na več slovenskih javnih in zasebnih visokošolskih zavodih. Od leta 2013 je zaposlen v svojem podjetju RE-FORMA, d.o.o. kot svetovalec in raziskovalec. Kot mednarodni ekspert dela za OECD in na projektih tehnične pomoči, ki jih financira EU, v regijah zahodnega Balkana in vzhodnega partnerstva, in sicer na področju koordinacije razvojnih in ekonomskih politik, upravljanja javnih financ in reform javne uprave.

Prof. dr. Janez Šušteršič is a full professor of economics. Between 2000 and 2007, he was Director of the Institute for Macroeconomic Analysis and Development and in 2012 Minister of Finance. He coordinated the preparation of two development strategies of Slovenia and was the Vice-Chairman of the Economic Policy Committee of the EU Council of Finance Ministers. He has lectured at several Slovenian public and private higher education institutions. Since 2013, he is employed in his company RE-FORMA, d.o.o. as a consultant and researcher. As an international expert, he works for the OECD and on EU-funded technical assistance projects in the Western Balkans and the Eastern Partnership regions, in the areas of development and economic policy coordination, public financial management and public administration reform.

Simona KUKOVIČ je docentka za področje politologije. Primarno področje njenega raziskovanja je politično in upravno (lokalno) vodenje, širše pa proučuje javno vodenje, primerjalne regionalne in lokalne oblasti, javno upravo ter upravne in politične procese ter institucije. Dr. Kukovič je urednica mednarodne znanstvene revije *Journal of Comparative Politics* (JCP), ki je abstrahirana v Web of Science in Scopusu. Aktivnosti dr. Kukovič segajo v mednarodni prostor, saj je članica izvršilnega odbora Central European Political Science Association (CEPSA), pa tudi članica ekspertne skupine Local Politics Specialist Group, ki deluje pod okriljem Political Studies Association (PSA) ter mednarodnih politoloških združenj, kot so American Political Science Association (APSA), International Political Science Association (IPSA); aktivna pa je tudi v slovenskem Politološkem društvu, kjer je od leta 2019 članica nadzornega odbora. Dr. Kukovič je

bila leta 2015 gostujoča raziskovalka na Local Goverment Research Unit pri DeMontfort University, Leicester (VB), leta 2018 pa gostujoča profesorica na University of North Carolina at Chapel Hill (ZDA) in na Paris Lodron University of Salzburg (AT). Dr. Kukovič je nosilka večih mednarodnih projektov; od septembra 2018 do avgusta 2020 pa je tudi nosilka podoktorskega projekta z naslovom »Vodenje lokalne skupnosti: birokratizacija politike ali politizacija birokracije?«.

Simona KUKOVIČ is assistant professor of political science. Her primary research area is political and administrative (local) leadership; in broader sense her research focus encompasses public leadership, comparative regional and local authorities, public administration as well as administrative and political processes and institutions. Dr. Kukovič is editor of the international scientific journal entitled Journal of Comparative Politics (JCP), which is abstracted in Web of Science and Scopus. Activities dr. Kukovič reach the international arena as she is a member of the Executive Board of the Central European Political Science Association (CEPSA), as well as a member of the Local Politics Specialist Group, an expert group under the auspices of the Political Studies Association (PSA) and international political associations such as American Political Science Association (APSA), International Political Science Association (IPSA); she is also active in the Slovenian Political Science Association, where she has been a member of the Supervisory Board since 2019. In 2015, dr. Kukovič was a visiting researcher at the Local Goverment Research Unit at DeMontfort University, Leicester (UK), and in 2018 a visiting professor at the University of North Carolina at Chapel Hill (USA) and at Paris Lodron University of Salzburg (AT). Dr. Kukovič is the holder of several international projects; from September 2018 to August 2020, she is also the holder of a postdoctoral project entitled "Leading Local Community: Bureaucratisation of politics or Politicisation of Bureaucracy?"
