Reference nosilca / Lecture's references:

Gorazd Justinek je docent za področje mednarodnega poslovanja in docent za področje mednarodnih političnih, ekonomskih in poslovnih odnosov. Je nekdanji diplomat in ustanovni član Sektorja za gospodarsko diplomacijo na Ministrstvu za zunanje zadeve. Vrsto let je bil vodja sektorja za internacionalizacijo na Javni agenciji RS za podjetništvo in tuje investicije ter v času predsedovanja Slovenije EU opravljal delo svetovalca predsednika vlade za področje domačih makroekonomskih ter mednarodnih ekonomskih odnosov. Po vstopu Slovenije v OECD je koordiniral delo predstavnikov Slovenije v delovnih telesih OECD, sodeloval pri pripravi programskega proračuna Republike Slovenije ter makroekonomskih analizah in reformah v javni upravi. Dva mandata je bil tudi direktor nevladne Ustanove - Center za Evropsko prihodnost, ki prvenstveno izvaja mednarodno razvojno pomoč v državah ZB in je tudi nosilka več Horizon 2020 projektov. Je ustanovitelj in odgovorni urednik mednarodne znanstvene revije *International Journal of Diplomacy and Economy* (London), ter član uredniških odborov številnih drugih mednarodnih znanstvenih revij (Scopus in WoS).

Gorazd Justinek is assistant professor of International Business and assistant professor of international political, economic and business relations. He is a former diplomat and a founding member of the Division for Economic Diplomacy at the Ministry of Foreign Affairs of the Republic of Slovenia. He has been for several years also the Head of the Division for Internationalisation at the Public Agency of the Republic of Slovenia for entrepreneurship and foreign direct Investments and during the Slovenia's EU Council Presidency in 2008 the domestic macroeconomic and foreign economic relations adviser to the Prime Minister of the Republic of Slovenia. After Slovenia's accession to the OECD, he became the coordinator of Slovenia's representatives in the institutional bodies of the OECD in Paris and worked on the programme budget of Slovenia, macroeconomic analysis and reforms in public sector. For two mandates he was the CEO of a non-governmental Foundation – Centre for European Perspectives, the key implementation body of the Republic of Slovenia's development assistance in the Western Balkans and a research centre with several Horizon 2020 projects. He is the founder and Editor in Chief of *International Journal of Diplomacy and Economy* (Geneva), and a member of several other editorial boards of international scientific journals (Scopus and WoS).

Krešimir Puharič je bil rojen v Ljubljani. Po diplomi na Pravni fakulteti Ljubljani je na tej fakulteti tudi magistriral in doktoriral. Od leta 1973 naprej je bil zaposlen kot visokošolski sodelavec in učitelj. Leta 1985 je bil izvoljen za rednega profesorja za Gospodarsko pravo, Mednarodno gospodarsko pravo, Pogodbeno pravo in Pravo industrijske lastnine. 2. decembra 2010 pa ga je Univerza v Ljubljani imenovala za zaslužnega profesorja. Na

Gospodarski zbornici Slovenije je predsednik Stalne arbitraže od leta 1992 naprej. Kot arbiter je uvrščen na liste številnih tujih institucionalnih arbitraž, npr. Avstrije, Črne gore, Hrvaške, Makedonije, Srbije, Latvije, Kazahstana, Slovaške, itn. Je tudi član Avstrijskega in Švicarskega arbitražnega združenja ter Svetovnega združenja profesorjev intelektualne lastnine. Od leta 2007 naprej je tudi predsednik razsodišča za domenske spore pri ARNES-u. Bil je tudi predsednik, podpredsednik in član v več nadzornih svetih večjih slovenskih delniških družb. V več kot 370 strokovnih člankih in razpravah objavljenih doma in zunaj naših meja je obravnaval predvsem problematiko industrijske lastnine, prava gospodarskih družb, vrednostnih papirjev in arbitražnega prava. Kresimir Puharič was born in Ljubljana. After graduating from the Faculty of Law of Ljubljana at this college master's degree and doctorate. From 1973 onwards he was employed as a university teacher and colleague. In 1985 he was elected a full professor of business law, international commercial law, contract law and intellectual property law. In December 2010 he was appointed by the University of Ljubljana as a Professor Emeritus. On the Slovenian Chamber of Commerce President Permanent Court of Arbitration since 1992. As the arbiter is placed on a list of many foreign institutional arbitrations, for example. Austria, Montenegro, Croatia, Macedonia, Serbia, Latvia, Kazakhstan, Slovakia, etc. He is also a member of the Austrian and Swiss arbitration association and the World Association of Professors of intellectual property. From 2007 onwards, is also chairman of the tribunal for domain disputes in ARNES. He also served as President, Vice President and member of the supervisory boards of several major Slovenian public limited companies. In more than 370 scientific papers and discussions published both within and outside our borders is primarily addressed the issue of intellectual property, corporate law, securities law and arbitration.
