Vsebina:

- Eden glavnih problemov mednarodnih odnosov, svetovnega reda oz. geopolitike so meje in migracije. Na začetku bomo predstavili meje Rimskega imperija, njegovo razdelitev na vzhodni in zahodni del, selitev prestolnice l. 330 v Bizanc, propad Zahodnega Rima l. 476 in vsega cesarstva l. 1453. Spoznali bomo koncept imperija in njegove razlike glede na koncept nacionalne države. Ob tem bomo spoznali problem migracij in mej, ki niso samo geografsko-politične, ampak tudi meje nekega reda, so tudi kulturno civilizacijske meje, verske in tudi etnične.
- Sledi kratka predstavitev naslednika Zahodnega Rima - Svetega rimskega cesarstva in njegovih mej.
- Sledi obravnava širitve evropske integracije, njenih normativnih podlag in zgodovinskega poteka z osredotočenjem na vsakokratno specifično problematiko širitve in na vprašanje nadaljevanja širitve EU.
- Osrednja pozornost pri širitvi evropskih integracij je posvečena obdobju padca železne zaves in vprašanju novega evropskega reda, ki ga predstavlja Pariška listina o novi Evropi.
- V nadaljevanju je obravnavano udejanjanje paradigem *vrnitev v Evropo* ter *celovita in svobodna Evropa*; obravnavali bomo vlogo Nata in njegovo širitev, širitev EU (2004-2013) ter perspektivo širitve EU na območju JV Evrope (bivša Jugoslavija minus

Content (Syllabus outline):

- This class focuses on two important issues for international relations, world order, and geopolitics: borders and migrations. At the beginning, we present the borders of the Roman Empire, its division into Eastern and Western parts, the transfer of its capital to Byzantium (330 a.d.), the demise of Western Rome (476 a.d.), and then of the rest of the empire in 1453. We will discuss the concept of empire and compare it to the concept of the nation state. At the same time, we introduce and discuss the issues of migrations and borders, which are not only geographical-political, but also borders of a certain order (cultural-civilizational, religious, and even ethnic borders).
- The following section is a brief presentation of the successor of Western Rome - the Holy Roman Empire and its borders.
- We will deal with the enlargement of European integration, its normative bases and historical course, focusing on the specific issues of each enlargement and on the question of the continuation of EU enlargement.
- The main focus of the enlargement of European integration is on the period of the fall of the Iron Curtain and the issue of the new European order represented by the Paris Charter for a New Europe.
- The implementation of the paradigms of *return to Europe* and *Europe whole and free* are discussed below. We will discuss the role of NATO and its enlargement, the enlargement of the EU (2004-2013),



Slovenija in Hrvaška, plus Albanija). Ta sklop se zaključi z obravnavo evropske sosedске politike z osvetlitvijo problematik Unije za Sredozemlje (politični pretresi so sprožili izreden migracijski pritisk na Evropo) ter vzhodnega partnerstva (zamrznjeni spori in barvne revolucije) s poudarkom na geopolitičnih vidikih spričo vojne Rusije proti Ukrajini.

and the prospects of EU enlargement for the region of SE Europe (former Yugoslavia minus Slovenia and Croatia plus Albania). This section concludes with a discussion of the European Neighborhood Policy, which sheds light on the issues of the Union for the Mediterranean (political turmoil has triggered extreme migratory pressure on Europe) and the Eastern Partnership (frozen conflicts and color revolutions) with an emphasis on geopolitical aspects in the light of Russia's war against Ukraine.
