Cilji in kompetence:

Študentje bodo razvili **splošne kompetence**:

- sposobnost za reševanje in kritično presojo konkretnih strokovnih problemov z uporabo znanstvenih metod in postopkov v primerih migracij in migrantov;
- koherentno obvladovanje temeljnega znanja, pridobljenega predvsem pri obveznih predhodnih predmetih ter interdisciplinarnega povezovanje znanja z različnih področij in njegova uporaba v primerih povezanih z migracijami in migranti;
- razumevanje splošne zgradbe in vsebine družboslovnih ved ter povezanosti med njenimi poddisciplinami, predvsem mednarodnim pravom in mednarodnimi odnosi ter diplomacijo;

Objectives and competences:

Students will develop the following **general competences**:

- a good command of research methods and procedures, and the ability of critical judgement in concrete cases concerning migrations and migrants;
- a coherent understanding of the basic aspects of previous lectures and interconnecting and applying knowledge interdisciplinary in cases concerning migrations and migrants;
- the knowledge of the general structure and content of social sciences and of the connections between its subdisciplines, notably international law and international relations, and diplomacy;

- razumevanje in uporaba kritične analize in razvoja teorij ter njihova uporaba pri reševanju konkretnih problemov migracij in migrantov;
- sposobnost opazovanja, iskanja in identificiranja ustreznih informacij v zvezi z migracijskimi vprašanji;
- dovzetnost za nove pristope in metode reševanja problemov pri transnacionalnih migracijah;
- sposobnost oblikovanja različnih modelov upravljanja migracij in povzemanja rešitev, ki iz njih izhajajo.

Študentje bodo razvili **predmetno-specifične kompetence**:

- sposobnost poglobljene analize, sinteze in predvidevanja rešitev ter posledic pojavov na področju globalnega upravljanja migracij, kakor tudi prava, politik in delovanja EU na področju migracij, azila ter integriranega upravljanja meja,
- sposobnost uporabe znanj s področja mednarodnega prava in mednarodnih odnosov ter diplomacije v praksi pri obravnavanju situacij, povezanih z migracijami, azilom, begunci, razseljenimi osebami ter drugimi posebno ranljivimi skupinami migrantov,
- avtonomnost pri strokovnem delu in pri sprejemanju pravih odločitev na področju migracij, azila

- a good understanding, critical analysis and development of theories and their application in solving concrete problems concerning migrations and migrants.
- the ability to observe, search for and identify appropriate information regarding migration issues;
- susceptibility to new approaches and methods of solving problems in transnational migrations;
- the ability to design different models of migration governance and summarise solutions deriving from them.

Students will develop the following **subject-specific competences**:

- the ability to analyse in depth, synthesise and anticipate solutions and consequences of phenomena in the field of global migration governance, as well as the EU law, policy and functioning in the field of migration, asylum and integrated border management,
- the ability to use knowledge of international law and international relations, and of diplomacy in practice when dealing with situations, connected with migrations, asylum, refugees and internally displaced persons and other particularly vulnerable migrant groups,
- the autonomy in making professional and correct decisions in the field of migration, asylum and state and EU external borders' management,

- razumel vpliv globalizacije in transnacionalne mobilnosti oseb na globalno varnost, mednarodni mir, gospodarski razvoj, trgovino, zaposlovanje, zdravstvo in izobraževanje;
- spoznal različne koncepte globalnega upravljanja;
- ločil med vlogo, načini in posledicami migracij v preteklosti ter v času globalizacije;
- poznal delovanje multilateralne diplomacije in oblikovanje zavezujočih norm ter mehkega prava (resolucije, deklaracije, sklepi, smernice ipd.) v mednarodnih in regionalnih organizacijah na področju migracij;
- razumel delovanje, procese odločanja in s tem povezane izzive na področju celovite politike EU o migracijah in azilu;
- poznal diplomatske aktivnosti EU na področju migracij;

Intended learning outcomes:

Knowledge and understanding:

Students will:

- get fully acquainted with main features of the development of migration law and policies through the prism of global governance;
- understand the analytical interlink between international law, international relations and diplomacy;
- understand the effects of globalisation and transnational human mobility on global security, international peace, economic development, trade, employment, health and education;
- get to know different concepts of global governance;
- distinguish between the role, types and implications of migration in the past and in the time of globalisation;
- know the functions of multilateral diplomacy in developing and making binding norms and soft law (resolutions, declarations, decisions, guidelines, etc.) in international and regional organizations;
- understand the functioning, decision-making and related challenges concerning a comprehensive EU migration and asylum policy;
- understand the EU diplomatic activities concerning migration;

- razlikovati prioritete pri migracijskih in azilnih politikah EU;
- razumel vlogo in načine financiranja EU za migracijske, azilne in integracijske politike;
- poznal ustanovna načela in delovanje mednarodnih multilateralnih institucij, ki se ukvarjajo z vprašanji migracij ter potek mednarodnih pogajanj na tem področju;
- razumel področje delovanja multilateralnih mednarodnih institucij (npr. Mednarodna organizacija za migracije in Agencija ZN za begunce) ter regionalnih migracijskih ureditev (npr. EU);
- znal pravno pravilno urejati primere v zvezi z migranti in migrantstvom;
- znal ustrezno voditi postopke v zvezi z azilom in azilanti;
- znal povezati aktualna mednarodna dogajanja na področju migracij ter vplive, ki jih slednja povzročajo za vsakdanje življenje v Sloveniji ter razumel vlogo multilateralne diplomacije v tem kontekstu.

- understand the role and various EU funding forms for migration, asylum and integration policies;
- know the foundational principles and functioning of international multilateral institutions dealing with migration issues and the process of international negotiations in the field;
- understand the scope of multilateral international organizations (e.g., IOM and the UN Refugee Agency) and regional migration arrangements (e.g., EU);
- be able to legally correctly solve cases with migrations and migrants;
- be able to correctly apply procedures for asylum seekers;
- be able to connect the present international events in the field of migration and the consequences that they cause for everyday life of people in Slovenia and understand the role of multilateral diplomacy in this context.

Gregor Maučec je docent za področje mednarodnega in kazenskega prava. Doktoriral je iz mednarodnega javnega prava na Pravni fakulteti Univerze v Mariboru. Svojo znanstveno-strokovno usposobljenost je nadgrajeval kot podoktorski raziskovalec na Pravni fakulteti Univerze v Københavnu (kot Marie Skłodowska-Curie Fellow), Evropskem univerzitetnem inštitutu v Firencah (kot Max Weber Fellow) in Pravni fakulteti Univerze v Kyotu (kot JSPS Postdoctoral Fellow). Njegovo raziskovanje in objave se ukvarjajo z mednarodno sodno funkcijo, zlasti s tem, kako jo razumejo in izvajajo sodniki raznih mednarodnih sodnih teles; z vedenjem in odločanjem mednarodnih sodnikov; z mednarodno sodno zaščito manjšin in avtohtonega prebivalstva; z mednarodnimi in internacionaliziranimi kazenskimi sodišči in tribunali; z diskriminacijo in poštenim sojenjem v kazenskem pravosodju, zlasti pri uporabi smrtne kazni; z vprašanji tranzicijske pravičnosti v pokonfliktnih družbah; ter s politikami in pravom EU na področju upravljanja meja, migracij in azila. Gregor Maučec is an assistant professor of international and criminal law. He received his PhD in Public International Law from the University of Maribor Faculty of Law. Previously, he was a Marie Skłodowska-Curie Fellow at iCourts - the Centre of Excellence for International Courts at the University of Copenhagen Faculty of Law, Max Weber Postdoctoral Fellow in Law at the European University Institute and JSPS Postdoctoral Fellow at the School of Law, Kyoto University. His research and writing has focused on the international judicial function, and particularly how it is understood and carried out by the judges of different international adjudicative bodies; international judicial behavior and decision-making; protection of minorities and indigenous populations through international courts; international(ised) criminal courts and tribunals; discrimination, fair trial, criminal sentencing and the death penalty; various transitional justice issues in the post-conflict societies; and EU policies and law on the management of borders, migration and asylum. He regularly participates in scientific symposia and outstanding conferences, and attends various pedagogical trainings in the field of higher education. He has also guest lectured at the University of Copenhagen, University of Florence and University College London. Since 2010, he has been a member of the editorial board of Book collection on international law.
