(**) In point 6, proof of payment of the administrative fee must be submitted when submitting a request for the issuance of a duplicate diploma

(***) under point 7, the faculty may not charge for the following conclusions:

- decision on meeting the conditions for taking exams from the senior year
- decision on the recognition of exams within NU
- decision on the early completion of exams
- decision on faster advancement
- decision on changing the elective subject
- decision on parallel studies at other faculties or universities
- decision to extend the deadline for the production of the final work
- a decision to raise the grade

- decision on granting the status of a student with special needs
- decision on the recognition of non-formal education

(****) The value of an ECTS credit point (ECTS) is used to calculate the remaining obligations for citizens and in the preparation of indicative enrollment offers. The basic unit for calculation is the ECTS, with its value determined by dividing the total tuition fee by the number of ECTS in a given academic year. The academic year lasts 12 months and comprises 60 ECTS.
