Študenti bodo:

- razumeli temeljne oblike in vzroke okoljske kriminalitete;
- poznali slovenski, evropski in mednarodni pravni okvir;
- pridobili sposobnost analize konkretnih primerov okoljske kriminalitete;
- razumeli mehanizme nadzora, preiskovanja in sankcioniranja;
- razvili sposobnost prepoznavanja tveganj v okoljskih politikah in upravnih postopkih;
- razvili kritičen odnos do okoljskih vprašanj in trajnostnega upravljanja.

Objectives and competences:

Students will:

- understand fundamental forms and causes of environmental crime
- know the Slovenian, European and international legal framework
- acquire the ability to analyse concrete environmental crime cases
- understand mechanisms of control, investigation and sanctioning
- recognise risks in environmental policies and administrative procedures
- develop critical awareness of environmental issues and sustainable governance

Predvideni študijski rezultati:

Po uspešno opravljenem predmetu bo študent:

1. razložil ključne pojme, pravne vire in institucije na področju okoljske kriminalitete;
2. analiziral konkretne primere kaznivih dejanj in prekrškov zoper okolje;
3. prepoznal in presodil tveganja za korupcijo, organizirano kriminaliteto in zlorabe na področju okoljskih projektov;
4. razumel delovanje institucij pregona in nadzora;
5. samostojno izvajal analize okoljskih tveganj in pravnih posledic;
6. kritično ocenil učinkovitost pravnih in upravnih mehanizmov za zaščito okolja.

Intended learning outcomes:

Upon successful completion of the course, the student will:

- explain key concepts, legal sources and institutions in environmental crime
- analyse concrete cases of environmental offences and misdemeanours
- identify and assess risks of corruption, organised crime and abuse in environmental projects
- understand the functioning of enforcement and supervisory institutions
- independently perform analyses of environmental risks and legal consequences
- critically assess the effectiveness of legal and administrative environmental protection mechanisms

Breda Mulec se je rodila 29. maja 1975 v Mariboru. Diplomirala je na Pravni fakulteti Univerze v Mariboru. Magistrirala je na Fakulteti za politične znanosti, pravo in javno administracijo Univerze v Atenah (2001) in na Pravni fakulteti Univerze v Mariboru (2002). V letih 2001 in 2002 je sodelovala z **Inštitutom za etnične, regionalne in sociološke študije (ECERS)** v Mariboru **ter ISCOMET mednarodno organizacijo**, kjer se je ukvarjala z manjšinsko problematiko v Sloveniji in širom po Evropi. Njena raziskovalna področja so bila etnična in verska vprašanja, človekove pravice, čezmejno sodelovanje, politični, jezikovni, kulturni in etničnimi vidiki evropske integracije ter dileme učinkovitega delovanja institucij EU. Leta 2002 se je za nekaj let zaposlila v **Državnem zboru RS**, kjer je bila sekretarka **Komisije za odnose s Slovenci v zamejstvu in po svetu**.

Sodelovala je tudi pri izvajanju mednarodne dejavnosti v Državnem zboru in pri prvem predsedovanju Slovenije EU na področju kulture.

Osrednji poudarek obeh magistrskih študijev je bil na varstvu manjšin in evropskih integracijah. Tako je npr. magistrski študij na Pravni fakulteti v Mariboru sklenila z magistrsko nalogo na temo Political, Ethnic, Cultural and Linguistic Aspects of the EU Integration.

Doktorirala je na Pravni fakulteti Univerze v Ljubljani iz ekonomske analize prava in evropskih integracij na temo Kohezijska politika EU in problemi njene implementacije s posebnim poudarkom za Republiko Slovenijo ter države Jugovzhodne Evrope. Od novembra 2007 se je kot **vodja sektorja za pravne zadeve in vodenje javnih naročil na Ministrstvu za okolje in prostor** tudi v praksi ukvarjala s področjem evropske kohezijske politike ter izvajanjem večjih investicijskih okoljskih projektov ter javnih služb varstva okolja. Od 2009-2011 je bila zaposlena v **kabinetu ministra, pristojnega za Slovence v zamejstvu in po svetu** akad. dr. Boštjana Žekša, kjer se je ukvarjala s strateškimi projekti, s poudarkom na kroženju možganov, gospodarskim sodelovanjem in kulturno dediščino. Od 18. februarja 2013 do novembra 2018 je vodila **Sektor za investicije in ekonomsko upravljanje na Ministrstvu za okolje in prostor**. Odgovorna je bila za pravna, finančna in ekonomska vprašanja ter kontrole na področjih izvajanja večjih okoljskih investicijskih projektov, sofinanciranih s sredstvi EU.

Od novembra 2018 do marca 2019 je vodila **Službo za mednarodno sodelovanje na Ministrstvu za javno upravo**. V času službovanja na MJU je za skoraj leto dni prevzela tudi **vođenje službe za stike z javnostmi**.

Od 16.3.2020 do 31.5.2022 je bila **vodja kabineta ministra zaposlena na Ministrstvu za kulturo.**

V času predsedovanja Slovenije Svetu EU je bila uradna govorka ministrstva za kulturo.

Trenutno je zaposlena na Uradu za razvoj in kakovost izobraževanja na Ministrstvu za šolstvo.

Dr. Mulec sodeluje pri pedagoškem delu v okviru predmetov Pravo javnih služb, Okoljsko in urbano pravo, Uslužbeno pravo in Upravno poslovanje na **Fakulteti državnih in evropskih študij** Nove Univerze v Ljubljani ter pri predmetu Socialni dialog in reševanje konfliktov na **Evropski pravni fakulteti**.

Kot gostujoča predavateljica je predavala večkrat tudi v tujini (Španija, Latvija, Češka, Severna Makedonija, Madžarska, Francija, Gruzija) in sicer v angleškem, španskem in hrvaškem jeziku.

Dr. Mulec je avtorica številnih strokovnih člankov in dveh znanstvenih monografij. V prostem času piše tudi literaturo, med drugim tudi otroške pravljice.

CURICULUM VITAE (Associate Professor MULEC BREDA, PH. D)

Breda Mulec, PH.D was born on 29 May 1975 in Maribor. She graduated from the Faculty of Law at the University of Maribor. She received her Masters Degree from the Faculty of Political Science, Law and Public Administration at the University of Athens (2001) and the Faculty of Law at the University of Maribor (2002). Breda Mulec earned a PhD in law from Ljubljana University. Her thesis is titled, »Economic Analysis of law with Emphasis on EU Cohesion policy and its Implementation Problems, with particular Emphasis on the Republic of Slovenia and the Countries of South Eastern Europe.« The main focus of the postgraduated studies was the protection of minorities and European integration.

In 2001 and 2002 she worked at the **Institute for Ethnic, Regional and Sociological Studies (ECERS)** in Maribor and **ISCOMET** organization, where she was involved in minority issues and projects regarding interregional cooperation in Slovenia and throughout Europe.

Her research areas were ethnic and religious issues, cross-border cooperation, political, linguistic, cultural and ethnic aspects of European integration and the dilemmas of the effective functioning of the EU institutions. Afterwards, she was working a few years for the **National Assembly**.

Since November 2007, as a Head of the department for Legal Affairs and the public procurement at the **Ministry of Environment and Spatial Planning** she was dealing in practice with the EU Cohesion Policy. From 2009-2013 she worked in the **Minister Office responsible for Slovenians Abroad** akad. dr. Boštjan Žekš, where she worked on strategic projects, with an emphasis on the brain talent circulation and economic cooperation. From 18 February 2013 – november 2018, she was employed at **Ministry of Environment and Spatial planning** as a Head of the Department of the environmental investments. She was dealing with legal, financial and economic issues and control over the major environmental investment projects co-financed by EU funds.

From November 2018 to March 2019, she headed the International Cooperation Service at the **Ministry of Public Administration**. During her service at the MPA, she was for almost a year also

responsible for the public relations of the Ministry. She was the Head of the Minister's Cabinet at the **Ministry of Culture** (15.3.2020-31.5.2022). During Slovenian Presidency of the EU Council (1.7.2021-31.12.2021) she was also spokesperson for the ministry.

Currently she is employed at the **Ministry of Education**.

Dr . Mulec also teaches at the **Graduate School of Government and European Studies in Kranj** and **European law school in Ljubljana**. She is author of several articles and the books on the topics of public administration.
