**Pogoji za vključitev v delo oz. za opravljanje  
študijskih obveznosti:**

Pogoj za vključitev v delo je vpis v letnik študija. Priporočeno je poznavanje osnov sistema javne uprave. Vsaj 80% prisotnost na predavanjih.

**Prerequisites:**

Students are allowed to participate in the course provided that they have completed the enrolment procedure. Basic knowledge of public administration system is recommended. At least 80% attendance at lectures.

**Vsebina:**

Predmet "Vodenje v javni upravi" študentom omogoča razumevanje koncepta vodenja, pa tudi vpogled v prevladujoče teorije in modele vodenja s poudarkom na prakse vodenje v javni upravi. Medtem ko splošne teorije vodenja prevladujejo v vseh sektorjih, vodenje javne uprave na splošno in specifičnih institucij javnega sektorja zahteva posebno znanje in razumevanje značilnosti teh institucij.

Predmet "Vodenje v javni upravi" je sestavljen iz naslednjih vsebinskih sklopov:

- Evolucija vodenja (korenine vodenja)
- Koncept vodenja (sestavine, proces)
- Vodenje vs menedžment

**Content (Syllabus outline):**

The course "Leadership in Public Administration" provides students with the capability to understand what leadership is as well as an insight to prevailing leadership theories and models focusing on leadership practices in public administration. While general leadership theories prevail all the sectors, leading public administration in general and specific institutions within public sector requires special knowledge and understanding of the characteristics of these institutions.

The course "Leadership in Public Administration" consists of the following content sets:

#### **Cilji in kompetence:**

Cilji predmeta vključujejo osvojitev znanja, veščin in izkušenj, ki jih (lahko) zaposleni v javnem sektorju neposredno uporabljajo v svojem zahtevnem in spremenljajočem se delovnem okolju. Predmet pripravlja študente za prevzem vodstvenih mest, zlasti v javni službi.

- sposobnost analize kompleksnih znanstvenih problemov in pravilnega sklepanja z uporabo kvalitativnih in/ali

#### **Objectives and competences:**

The objectives of the course include providing knowledge, skills, and experience that can be directly utilized by public sector professionals in their challenging and changing work environment. The course prepares students for positions of leadership, particularly in the public service.

#### **Students will develop the following general competences:**

- detailed understanding of research, analytical methods and theories in the thematic areas of public policy and public administration;
- to summarize and (critically) assess highly specialized literature in the thematic areas of public policy, public administration and public leadership;
- ability to analyse complex scientific problems and to draw correct conclusions

vloge javnega vodenja; temeljni poudarek pa je tudi v aplikativni naravnosti predmeta, kar omogoča študentom pridobivanje veščin s področja političnega, upravnega in civilnodružbenega vodenja. Tako teoretična kot praktična znanja, ki jih bodo študenti pridobili, bodo služila kot temelj lastnega dojemanja in kritičnega mišljenja ter evalvacije upravljanja in delovanja različnih uprav, entitet, institucij, organizacij, držav ter nadnacionalnih sistemov.

V sklopu predmeta bo poseben poudarek namenjen vodenju v strukturah javne uprave, kar bo doprineslo k uporabnosti pridobljenih znanj, kompetenc in veščin tudi kasneje v času poklicne kariere študentov v državnih institucijah, mednarodnih organizacij ter organih oz. upravah na različnih nivojih oblasti.

Ob zaključku tega predmeta bodo študentje imeli osnovno razumevanje konceptov vodenja, različnih vodstvenih pristopov in sposobnost uporabe različnih veščin in tehnik, za katere se šteje, da so ključnega pomena za uspešno vodenje v dejanskem organizacijskem kontekstu in širši družbi.

The course is partially designed as a review of theoretical and evolutionary concepts of public leadership that will help students to understand the basic concept and role of public leadership; the main emphasis is also on the applied orientation of the course, which enables students to acquire skills of political, administrative and civic leadership. Both, theoretical and practical knowledge will serve as the basis for their own perceptions and critical thinking and the evaluation of the management as well as functioning of different administrations, entities, institutions, organizations, countries and transnational systems.

Special emphasis will be placed on leadership in public administration structures, which will contribute to the usefulness of acquired knowledge, competences and skills even later in the students' professional careers in national, international organizations and bodies or administrations at different levels of government.

Absorbing this course, students will have the basic understanding of leadership concepts, different leadership approaches, and abilities to apply various skills and techniques deemed to be essential for successful leadership to actual organizational context and broader societal setting.

**Reference nosilca / Lecture's references:**

**Dr. Simona Kukovič** je izredna profesorica za področje politologije. Doktorirala je leta 2015 s področja politologije – javne uprave na Fakulteti za družbene vede Univerze v Ljubljani. Strokovno področje dr. Kukovič je politično in upravno lokalno vodenje, širše pa preučuje vodenje, primerjalne regionalne in lokalne oblasti, lokalno demokracijo in participacijo, javno upravo ter upravne in politične procese ter institucije. Je slovenska predstavnica v mrežah COST, članica izvršilnega odbora Central European Political Science Association (CEPSA) in glavna urednica mednarodne znanstvene revije Journal of Comparative Politics. Dr. Kukovič je bila gostujoča profesorica/raziskovalka na večih univerzah, med drugim DeMontfort University, Leicester, Velika Britanija (2015), University of North Carolina at Chapel Hill, Severna Karolina, ZDA (2018) ter na Paris Lodron University of Salzburg, Avstrija (2018–2019). Bila je nosilka podoktorskega projekta “Vodenje lokalne skupnosti: birokratizacija politike ali politizacija birokracije?” (2018–2020) ter petih bilateralnih projektov med Republiko Slovenijo in ZDA, Črno goro, Avstrijo ter Bosno in Hercegovino. Od januarja 2022 nosi naziv Jean Monnet Chair. Je (so)avtorica več znanstvenih publikacij; med monografijami velja izpostaviti “Slovenian Politics and the State” (Lexington Books, Rowman & Littlefield, ZDA) ter “Political system of Slovenia” (Sampark, Kalkuta, Indija). V domačem prostoru je poznana po znanstvenih delih s področij lokalnega vodenja in lokalne samouprave, prav tako je avtorica standarda kakovosti “Upravljavaška sposobnost občin (USO)”.

**Dr. Simona KUKOVIČ** is an associate professor of political science. She received her PhD in Political Science - Public Administration from the Faculty of Social Sciences, University of Ljubljana in 2015. Dr. Kukovič's area of expertise is political and administrative leadership at the local level. She also conducts research in the areas of leadership, comparative regional and local government, local democracy and participation, public administration, and administrative and political processes and institutions. She is the Slovenian representative in the COST networks, a member of the executive board of the Central European Political Science Association (CEPSA) and a general editor of the international scientific journal Journal of Comparative Politics. Dr. Kukovič has been a visiting professor/researcher at several universities, including DeMontfort University, Leicester, UK (2015), University of North Carolina at Chapel Hill, North Carolina, USA (2018), and Paris Lodron University Salzburg, Austria (2018-2019). She was the head of the postdoctoral project entitled "Leading the Locality: Bureaucratization of Politics or Politicisation of Bureaucracy?" (2018-2020) and five

bilateral projects between the Republic of Slovenia and the USA, Montenegro, Austria, Bosnia and Herzegovina. As of January 2022, she holds the title of Jean Monnet Chair. She is (co-)author of several scientific publications, including the monographs "Slovenian Politics and the State" (Lexington Books, Rowman & Littlefield, USA) and "Political System of Slovenia" (Sampark, Calcutta, India). In Slovenia, she is known for her academic work in the field of local leadership and local self-government. She is also the creator of the quality standard "Municipal Administrative Capacity".
