**Content (Syllabus outline):**

The course (*International Status and Foreign Policy of Slovenia*) analyzes the historical and practical circumstances, limitations, and

vključevanju Slovenije v mednarodno skupnost in pri njenem položaju v njej.

Predavanja se osredotočajo na temelje zunanjepolitične analize, na sodobni mednarodni/evropski sistem in njegovo genezo z vidika pomena za slovensko državnost in na specifične izzive malih držav v mednarodnem sistemu. Predavanja se osredotočajo na glavne dosežke slovenske zunanje politike in izzive v luči aktualnih razmer v mednarodni skupnosti, predvsem v EU in med EU in drugimi državami oz. organizacijami.

Lectures focus on the foundations of foreign policy analysis; the modern international / European system and its genesis from the perspective of significance for Slovenian statehood; and the specific challenges of small states in the international system. Lectures also analyze the main achievements of Slovenian foreign policy and its challenges in light of the current situation in the international community – primarily within the EU and between the EU and other states and organizations.

It is also intended to contribute to knowledge of Slovenia's diplomatic history, to the ability of students to understand the international position of the Republic of Slovenia and its national interests, also in the context of the actual policy-making agenda.

Academic success will be linked to prior knowledge of foreign languages, European and Slovenian history, the basics of international relations and an international outlook.

To help provide some background and theory on foreign policy, European affairs and geopolitics students are encouraged to look at some of the texts on the above reading list in advance of taking the class.
